2022 DISTINGUISHED CITIZEN AWARD

Award Nomination Guidelines

The Menomonie Area Chamber & Visitor Center will recognize an individual who has made a significant and positive impact in the Menomonie Area. Individuals selected for this award will not only be honored with an award from the Menomonie Area Chamber & Visitor Center, but also a Distinguished Citizen decree from the office of the Governor.

Attributes of Distinguished Citizen nominees are broad, as contribution and impact can be measured or determined in many different ways. Attributes of nominees may include but are not limited to: community leadership, organization involvement, heroic action, humanitarian efforts, service, volunteerism, notable business success, personal or professional achievements, or recognitions brought to the Menomonie Area as a result of an individual's effort. Nominees for this award have proven their personal and/or professional contributions to the community through an extended period of service and/or community involvement.

Eligibility Criteria

To be eligible for the Distinguished Citizen Award, nominees:

- Are not required to be a Chamber Investor
- Must have impacted the Menomonie Area through their personal and/or professional efforts
- May not be a current elected official; officials no longer in office are eligible for nomination
- Are not required to be retired; retired individuals are eligible
- Need not be a resident of the immediate Menomonie Area
- Model high ethical conduct in both their personal and professional activities

Individuals are only eligible to receive this award once in a lifetime. Nominees may receive nominations yearafter-year if they are not selected for an award. Nominations will remain in the selection pool for one year following the original nomination submission. Because of this, nominees who are selected are not notified of their nomination in an effort to ensure confidentiality.

Nominations that do not meet eligibility criteria or those without a completed nomination form inclusive of supporting narrative in each category will not be considered.

Application & Judging Process

Individuals that meet award eligibility criteria and receive a complete nomination will be considered for this award. Consideration of the top nominee will be given for most nominations and scoring from a criteria matrix set by the Menomonie Area Chamber & Visitor Center. The top nomination will be recommended by an award committee to the Chamber Board of Directors for final selection.

Nomination Process Timeline

December 1 - January 31: Nominations Accepted February: Nominations Reviewed March: Individuals Who Submitted a Nomination Are Notified of Acceptance or Regret May: Recipient Honored at the Annual Meeting & Awards (By Way of Surprise)

Those who submit nominations will be asked to help coordinate attendance of the award recipient at the Annual Meeting & Awards event. Award recipient information for this category will be NOT be released publicly prior to the Award night. Because of this, individuals involved in the nomination process are asked to not share the nomination with nominees, to continue our tradition of maintaining the element of surprise.
