

2022 SMALL BUSINESS OF THE YEAR AWARD

Award Nomination Guidelines

The Menomonie Area Chamber & Visitor Center will recognize a small business that personifies the spirit of entrepreneurship, pride and success that forms the backbone of our local economy. Businesses that are nominated should possess many of the following attributes:

Leadership

- -Manages change or adversity to achieve exceptional business growth
- -Maintains outstanding customer services, sound management and ethical business practices
- -Provides industry leadership with its products/services

Innovation

- -Demonstrates a willingness to take risks
- -Introduces creative products/services to the community
- -Strives to adapt and improve based on competition and market trends or needs
- -Recent innovative expansion

Employee Investment

- -Generates outstanding results through employee engagement and teamwork
- -Invests in employees through training, benefits and advancement opportunities
- -Maintains a dynamic culture that attracts and retains a highquality workforce

Community Service

- -Provides community leadership and sets an example
- -Offers support and volunteerism to community organizations
- -Advances economic growth by supporting other local businesses

Eligibility Criteria

To be eligible for the Small Business of the Year Award, businesses must:

- Have fewer than 25 full-time employees
- Be a Chamber Investor in good-standing
- Possess attributes such as those listed above

Businesses are only eligible to receive an award in this category once in a ten year timespan. Businesses may receive nominations year-after-year if they are not selected for an award. Nominations are only valid for the year they are submitted. If you are nominating a business, you are encouraged to verify eligibility. Nominations that do not meet eligibility criteria or those without a completed nomination form inclusive of supporting narrative in each category will not be considered.

Application & Judging

Businesses that meet award eligibility criteria and receive a complete nomination will be considered for this award. Consideration of the top nominee will be given for most nominations and scoring from a criteria matrix set by the Menomonie Area Chamber & Visitor Center. The top nominations will be recommended by an award committee to the Chamber Board of Directors for final selection.

Nomination Timeline

December 1 - January 31: Nominations Accepted

February: Nominations Reviewed

March: Nominees Notified & Top Nominees Publicly Announced

May: Nominees/Recipients Honored at the Annual Meeting & Awards

The top 3 Small Business of the Year nominees will receive one complimentary ticket to the Annual Meeting & Awards where the top Small Business of the Year nominees will be announced as the award recipient. Award recipient information for this category will not be released publicly until after the Award night.
